Fixed term contracts can be terminated once the appropriate early cancellation fee is paid to The Village Gym. Ongoing Casual Term Contracts can be cancelled at anytime with 14 days notice. This must be on The Village Gym Cancellation Form obtained for The Village Gym Reception. You acknowledge that you will provide 14 days written notice as per above, to terminate the membership contract. The termination notice period will involve payment for your final 14 days. The Village Gym will respond via email to receipt of a written termination notice within 7 days. The Village Gym will cancel the automatic debit arrangement upon confirmed termination of a direct debit contract. If you terminate the Contract or stop the automatic debit arrangement in a manner not described in the Contract, then you may be liable to The Village Gym for damages for breach of contract.
